The parties to a criminal case are the government and the accused criminal defendant. The attorneys for the government must advocate for the interests of society as a whole, which are sometimes different from the interests of the victim - the person directly affected by the crime. It is for this reason that victim advocates nationwide have fought for enforceable legal rights for crime victims, including the right to be represented by their own attorney as a way of ensuring an independent voice throughout the legal process.

OCVLC provides free legal representation to crime victims to help them assert their legal rights. We provide services regardless of race, gender identity, sexual orientation, ability, religion, class, ethnicity, age, income, or immigration status.

VICTIMS' RIGHTS

We provide free legal services in criminal cases for crime victims. We provide this service throughout Oregon. Victims of a crime that occurred in Oregon may be eligible for these services.

PROTECTION ORDERS

We provide free legal services to victims of domestic and sexual violence, elder abuse, and stalking with protective orders such as:
Family Abuse Prevention Act, Sexual Abuse Protective Order, Stalking Protective Order, Elderly Persons or Persons with Disabilities Abuse Prevention Act.

SUPPORT SERVICES

We provide support services, including: safety planning, informational support, help applying for Crime Victim Compensation and the Address Confidentiality Program, advocate accompaniment to report a crime or to go to court, help requesting police reports, and referrals to other agencies for issues outside the scope of services provided by OCVLC.
